

Coralia Liveboard Overview of Safety Standards and Measures

Our Commitment to Safety

Coralia Liveboard prioritises the safety and well-being of our guests and crew. We adhere to strict safety protocols and maintain comprehensive safety equipment to ensure a secure and enjoyable cruising experience. Considering recent events, we want to reassure our guests of our unwavering commitment to safety. This document outlines our safety standards and measures, covering everything from onboard equipment to crew training.

Safety Equipment

Our liveboard is equipped with the following safety equipment:

- Tenders – two speedboats
- Life rafts – four fully equipped life rafts that are serviced annually
- Satellite phone – in the Cruise Director cabin
- Emergency Oxygen – in the camera room and extra oxygen stored by the dive centre
- Medic First Aid Box – in the Cruise Director cabin
- Life jackets in all the guest and crew cabins
- Orange life rings and overboard device – on the top deck
- Automated External Defibrillator (AED) – stored in the camera room on the main deck
- EPIRB (Emergency Position Indicating Radio Beacon) – stored on the sky deck
- CCTV in the wheelhouse with cameras watching the engine room, galley, side ladder and back deck
- 24-hour watch – two crew are always on watch, one on deck and one in the engine room
- Smoke detectors – in all guest cabins and all around the boat
- Fire extinguishers – in all guest cabins and all around the boat
- Fire balls – in all common areas, in the galley and by the engine room
- Fire hoses – one by the engine room and one by the galley
- Fire suppression system in the engine room
- Fire suppression system in all electric panels
- Full firefighting suits – two, stored in the wheelhouse
- Fire escape masks – in all lower deck guest and crew cabins
- Navigation Equipment – GPS, compass, computer navigation, Furuno radar, depth sounder, VHF radio, and long-range radio

All safety equipment is serviced annually and regularly tested to ensure optimal functionality.

Safety Instructions for Guests

- Life Jackets: Life jackets are in a drawer in the cabin. Guests will be shown their location during the cabin briefing.
- Fire Escape Masks: For lower deck cabins, fire escape masks are in the life jacket drawer in the cabin. Guests will be shown their location during the cabin briefing.
- Emergency Procedures: Guests will be briefed on all emergency procedures, including evacuation routes, muster stations, and the use of safety equipment, during the welcome briefing soon after arrival.
- Dive and Snorkel Safety: A comprehensive dive and snorkel briefing will be conducted on the day of arrival, emphasising safe diving and snorkel practices and procedures. A dive/snorkel site briefing will be given before each dive or snorkel.
- Charging Devices: For safety reasons and to minimise fire risk, unattended charging of electronic devices in cabins is strictly prohibited. Guests are requested to charge devices in the camera room or restaurant where crew members are present.

Crew Training

All our crew members undergo rigorous training in the following areas:

- Fire safety training
- First aid training
- Emergency procedures
- Dive rescue techniques

Our crew regularly participate in drills to ensure preparedness for any situation.

Safety FAQs

Q: What fire safety measures are in place?

A: Our liveaboard is equipped with smoke detectors, fire extinguishers, fire balls, fire hoses, and a fire suppression system in the engine room and electric panels. We also have full firefighting suits and fire escape masks for lower deck cabins. Our crew is trained in fire safety procedures.

Q: What first aid equipment is available?

A: We have a Medic First Aid Box and Emergency Oxygen onboard. An Automated External Defibrillator (AED) is also available. Our crew is trained in first aid.

Q: How will we be informed about safety procedures?

A: Guests will receive a detailed safety briefing upon arrival, covering the location of safety equipment, emergency procedures, and dive safety guidelines.

Q: What communication systems are in place for emergencies?

A: We have a satellite phone and an EPIRB (Emergency Position Indicating Radio Beacon) for emergency communication.

Q: Is there 24-hour surveillance?

A: Yes, we maintain a 24-hour watch, and there is CCTV in the wheelhouse.

Q: Where are the life jackets located?

A: Life jackets are in a drawer in your cabin. You will be shown their location during the cabin briefing.

Q: Can I charge my electronic devices in the cabin?

A: No, for safety reasons, unattended charging of electronic devices in your cabins is strictly prohibited. We ask that you charge devices in the common areas.

Q: Is the safety equipment regularly checked?

A: Yes, all safety equipment is serviced annually and regularly tested to ensure it is in good working order.
